



Bone Sweet Bone Waiver

I hereby certify that I am the legal owner of _____. I understand and agree that in admitting my dog(s), Bone Sweet Bone inc. has relied on my representation that my dog(s) is/are in good health and have not harmed, shown aggression or threatening behavior towards any person or any other dog.

___ However, as this is a group play environment there are inherent risks that I accept.

___ Bone Sweet Bone will exercise reasonable care of the dog during its stay. Owner does acknowledge and he/she understands that their dog(s) will co-mingle with other dogs and that as a result their dog could incur injuries ranging from small cuts or scrapes to dog bites or other serious injuries in the course of normal dog play. In consideration of these services, owner expressly waives and relinquishes any claim against Bone Sweet Bone, its officers, owner employees and agents, relating to services provided pursuant to the owner's dog or related to interaction with other dogs, except those claims arising from willful misconduct by the Bone Sweet Bone, and further agrees to indemnify Bone Sweet Bone against all such claims.

___ I understand that I am solely responsible for any harm by my dog(s) to any other dog, employee, guest [person] while he/she is/are attending daycare or being groomed at Bone Sweet Bone.

___ I further release and discharge Bone Sweet Bone and its members and/or employees from any liability, claims and damage in connection therewith.

___ I hereby certify that the above named dog(s) is/are in good health, has not been ill with any known contagious diseases, and has been fully vaccinated for canine distemper, canine parvo virus, canine hepatitis, and canine parainfluenza, as well as bordetella (Kennel Cough), and rabies in accordance with local laws.

___ I understand that no dog shall be exempt from vaccination requirement unless there is a valid medical reason with proof supplies in writing by licensed veterinarian. Further I understand that Bone Sweet Bone strongly recommends both a regular flea control program and heartworm testing.

Therefore, I understand that Bone Sweet Bone reserves the right to permanently remove my dog(s) from daycare or grooming at any time for whatever reason.

___ Owner further agrees to the following conditions regarding pre-paid package. PRE-PAID DAYCARE PACKAGE ARE NON-REFUNDABLE. Pre-paid daycare cards expire ONE YEAR from the date of purchase. Unused days will be forfeited and will not be refunded or honored after the one-year period.

___ Owner gives permission for photos of their dog(s) to be taken by Bone Sweet Bone staff for use in advertising and promotion materials and social media. Bone Sweet Bone agrees not to sell or distribute these photos to any third party.
