SECTION 5: Firefighting measures

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Suitable Extinguishing Media: Not combustible. Use extinguishing media suited to burning materials.

Specific hazards arising from the chemical: The product itself is not combustible but it can support combustion, even in absence of air. On heating it melts and further heating can cause decomposition, releasing toxic fumes containing nitrogen oxides and ammonia. Decomposition products may include the following materials: nitrogen oxides, sulfur oxides, phosphorus oxides, ammonia, Avoid breathing dusts, vapors or fumes from burning materials., In case of inhalation of decomposition products in a fire, symptoms may be delayed.

Methods and Materials for Containment and Cleaning Up:
