Section 2: Hazard Identification



Flammable: Hazardous Ingredient Denatured Alcohol (CAS 64-17-5)40-50%

Emergency Overview:

This is a personal care product/cosmetic product that is should not be used around flame, spark or while smoking.

Potential health effects:

Skin: not expected to be irritating, sensitizing, photoallergenic or phototoxic when used as intended. If irritation does occur, it is expected to be mild and transient.

Eye: May cause mild and transient irritation.

Inhalation: Product is volatile due to alcohol.

Ingestion: When used as intended, it is not expected to cause gastrointestinal irritation.

Accidental ingestion of undiluted product may cause mild gastrointestinal distress such as nausea, vomiting or diarrhea.

Allergen: Benzyl Benzoate, Citronellol, Coumarin, Geraniol, Hexyl Cinnamal, Linalool, Alpha-Isomethyl Ionone

Section 4: First-Aid Measures

Procedures for spill/leak clean-up:
