4. FIRST AID MEASURES


Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

PPE for First Aiders: Wear safety shoes, overalls, gloves, chemical goggles. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact.
