Correct Posture to Use the Product

Use the product in the correct posture as follows:

- Straighten your back.
- Allow a distance of 45 to 50 cm between your eyes and the screen, and look slightly downward at the screen.
- Keep your eyes directly in front of the screen.
- Adjust the angle so light does not reflect on the screen.
- Keep your forearms perpendicular to your upper arms and level with the back of your hands.
- Keep your elbows at about a right angle.
- Adjust the height of the product so you can keep your knees bent at 90 degrees or more, your heels attached to the floor, and your arms lower than your heart.
- Do eye exercises or blink frequently to relieve eye fatigue.
- Use the product at the recommended resolution and frequency. —

Failure to do so may cause your eyesight to deteriorate.

- Looking at the screen too close for an extended period of time can deteriorate your eyesight.
- Rest your eyes for more than 5 minutes or look at distant objects for every 1 hour of product use.

Adjusting the Monitor

- For the best results, it is recommended to look directly at the front of the monitor and make any adjustments as necessary.
- Ensure that the monitor is mounted upright on the stand base.
- When adjusting the monitor viewing angles, avoid touching the screen and hold the stand in order to prevent it from falling over.

External Control Buttons



1 Power button

Short press the power button to turn the monitor on or off.

2 Joystick

- Push the joystick up to activate the quick settings menu's **Input** settings.
- Push the joystick down to activate the quick settings menu's **KVM** function settings.
- Push the joystick left to activate the quick settings menu's Gaming Plus settings.
- Push the joystick right to activate the quick settings menu's Local Dimming function settings.
- Short press joystick to activate the OSD menu.

When the OSD menu is activated:

- Push the joystick up/down/left/right to navigate and adjust settings.
- Push the joystick to enter a sub-menu.
- Push the joystick left to go back to the previous menu level or to exit the OSD menu.

3 Power light

- Blue: On
- Orange: Power Saving

Main Menu [Input]



- Enter the **Input** menu to switch the input signal.
 - **Type-C:** Sets the input signal source to the Type-C port.
 - DP: Sets the input signal source to the DP port.
 - HDMI 1: Sets the input signal source to the HDMI 1 port.
 - HDMI 2: Sets the input signal source to the HDMI 2 port.
 NOTE: The Input settings can also be adjusted in the quick settings menu. Refer to External Control Buttons on page 10 for more information.

[Picture Setting]



- Enter the Picture Setting menu to configure image settings.
 - Picture Mode: Enter the Picture Mode menu to adjust different picture modes.
 - a. Standard: Enables the standard picture mode.
 - b. User1: Provides customized options for user experience.
 - c. User2: Provides customized options for user experience.

- d. Movie: Provides the optimal setting for movie viewing.
- e. RTS: Provides the optimal setting for RTS (Real-Time Strategy) games.
- f. FPS: Provides the optimal setting for FPS (First Person Shooter) games to increase the visibility in dark scenes.
- g. MOBA: Provides the optimal setting for MOBA (Multiplayer Online Battle Arena) games.
- h. Photo: Provides the optimal setting for photo viewing.
- i. Text: Provides the optimal setting for reading.

NOTE: The picture mode will automatically be set to HDR Picture Mode when the monitor is connected to an input source that features an HDR output signal.

- Brightness: Adjusts the backlight brightness level of the monitor (0 to 100).
- Contrast: Adjusts the contrast level of the monitor (0 to 100).
- Black Stabilization: Adjusts the backlight brightness level (0 to 10) to illuminate dark areas without overexposing brighter areas.
- Aspect Ratio: Adjusts the aspect ratio of the monitor (Full / 16:9 / 4:3).
- **Sharpness:** Adjust the sharpness of the monitor (0 to 100).

[Color Adjustment]



- Enter the Color Adjustment menu to adjust color settings.
 - Color Temperature: Adjusts the color temperature of the monitor (6500K / 7500K / 9300K / User). User allows you to adjust the Red, Green and Blue values individually (0 to 100).
 - Gamma: Adjusts the gamma curve of the monitor (1.8 / 2.0 / 2.2 / 2.4 / 2.6).
 - 6-axis Color: Adjusts the hue and saturation of Red, Green, Blue, Cyan, Magenta, and Yellow on the monitor.
 - Color Domain: Sets the color domain of the monitor (Auto / RGB Mode / YUV Mode).
 - Color Space: Sets the color space of the monitor (Auto / sRGB / AdobeRGB / DCI-P3 / BT.2020).

[Gaming Setup]



- Enter the Gaming Setup menu to adjust gaming settings.
 - FreeSync: Enables/Disables the FreeSync technology which is supported by AMD's graphic cards (On / Off).
 - Over Drive: Configures the over drive function which makes the display's pixels transition colors faster (Off / Normal / Advanced / Ultrafast / Dynamic / User).
 - Ultra Low Latency: Enables/Disables the Ultra Low Latency function which helps speed up image processing (On / Off).
 - Gaming Plus: Configures the monitor's Timer, Crosshair and FPS Counter functions on the monitor.
 NOTE: The Gaming Plus settings can also be adjusted in the quick settings menu. Refer to External Control Buttons on page 10 for more information.
 - MPRT: Configures the MPRT (Moving Picture Response Time) function which reduces picture motion blur (Off / Low / Medium / High).

[Advanced Settings]



- Enter the **Advanced Settings** menu to configure the display's advanced settings.
 - **HDR:** Configures the monitor's HDR function (Off / Auto).
 - Local Dimming: Adjusts the local dimming function to improve the depth of blacks on the monitor's display (Off / Low / Medium / High).
 NOTE: The Local Dimming function settings can also be adjusted in the quick settings menu. Refer to External Control Buttons on page 10 for more information.
 - Max Brightness: Enables/Disables the max brightness function to increase the maximum display brightness of the monitor (On / Off).
 - HDMI Range: Adjusts the HDMI Range of the monitor (Auto / Full / Limited).
 - KVM: Configures the KVM function to control multiple computers with one keyboard, monitor and mouse (Off / USB Up / Type-C / Auto).
 NOTE: The KVM function settings can also be adjusted in the quick settings menu.
 Refer to External Control Buttons on page 10 for more information.
 - Power-Off USB Charge: Enables/Disables the power-Off USB charge function to charge connected devices via USB (On / Off).

[System]



- Enter the System menu to configure system settings:
 - Language: Sets the language to English, Simplified Chinese, Traditional Chinese, Korean, Japanese, Spanish, French, German, Italian, Vietnamese, Russian, or Finnish.
 - OSD Setup: Adjusts the OSD (On Screen Display) menu display Position, Timeout, Transparency, or enables/disables its lock function (On / Off). If the OSD menu is locked, push the joystick right and hold for three seconds to unlock it.
 - Audio: Mutes or adjusts the volume (0 to 100).
 - Information: Shows basic information about the monitor, such as Resolution, Frame Rate, HDR, FreeSync, H.Frequency, Pixel Clock, Serial Number, and Firmware Version.
 - Power Indicator: Adjusts the power indicator brightness level on the monitor (Off / Level 1 / Level 2 / Level 3).
 - Quick Boot: Enables/Disables the quick boot function which speeds up the monitor's boot-up process (On / Off).
 - Sleep: Selects the idle time before the monitor enters sleep mode (30 Minutes / 45 Minutes / 60 Minutes).
 - USB-Upgrade: Updates the monitor's firmware version via USB (Confirm / Cancel). Refer to Updating the Monitor Firmware on page 15 for more information.
 - **Reset:** Resets the monitor to factory settings (Confirm / Cancel).

Updating the Monitor Firmware

- 1. While the monitor is turned on, disconnect the power cable and all input sources from the monitor.
- 2. Copy the GP2711.bin firmware file onto a USB flash drive's root directory.
- 3. With the power cable still unplugged from the monitor, insert the USB flash drive into the USB-A port located next to the DC IN port.
- 4. Reconnect the power cable to the monitor to begin automatic updating of the firmware.
- The monitor will reboot after a "success" message has been displayed. The rebooting process will take two minutes and will not display any progress status, DO NOT disconnect the power cable from the monitor during this time.
- 6. When the monitor enters factory setting mode (displaying alternating flashes of different colors), check the moving information window on the display to confirm that the updated firmware version is correct, then press the power button (DC off), press it again (DC on) to revert to the normal display image, and remove the USB flash drive from the monitor.

NOTE: The USB flash drive must be in FAT32 format in order to successfully update the monitor's firmware.
