

Privacy Policy

Protecting your private information is our priority. This Privacy Policy applies to www.RCSRUS.com and RCSRUS and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to RCSRUS include www.RCSRUS.com and RCSRUS. By using the RCSRUS website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, RCSRUS may collect personally identifiable information, such as your first and last name, mailing address, and e-mail address. If you purchase RCSRUS's products and services, your billing and credit card information will not be collected or stored by RCSRUS but may be stored by a third party responsible for processing your payment. This information is used by the third party to complete the purchase transaction. RCSRUS may also collect anonymous demographic information, which is not unique to you, such as your age or gender. We do not collect any personal identifying information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Personal Information

RCSRUS treats any personal information you provide is confidential. RCSRUS collects and uses your personal information to operate its website(s) and deliver the services you have requested. RCSRUS may also use your personally identifiable information to inform you of other products or services available from RCSRUS and its affiliates.

Sharing Information with Third Parties

RCSRUS does not sell, rent or lease its customer lists to third parties. RCSRUS may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. RCSRUS may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by RCSRUS. Use of Cookies

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to: (a) complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us; (b) detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity; (c) debug to identify and repair errors that impair existing intended functionality; (d) exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law; (e) comply with the California Electronic Communications Privacy Act; (f) engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent; (g) enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us; (h) comply with an existing legal obligation; or (i) otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

RCSRUS does not knowingly collect personally identifiable information from children under the age of eighteen. If you are under the age of eighteen, you must ask your parent or guardian for permission to use this website.
