Under NO circumstance is 14.7 Solutions liable for ANY damages that occur to your engine, drivetrain or any part of your vehicle incurred during or after your vehicle is tested/tuned. If any part of your vehicle (including but not limited to the engine, turbos, intake system, exhaust system, driveline, transmission, differentials, tires, etc) experiences catastrophic failure during tuning and/or testing, 14.7 Solutions will NOT be held liable or responsible for the repair or replacement or cost thereof of the failed part(s). If your vehicle experiences catastrophic mechanical failure during testing/tuning and there is an outstanding balance with 14.7 Solutions for parts and/or services rendered before testing and tuning, payment in full is still owed to 14.7 Solutions, including the cost of the testing/tuning.

If 14.7 Solutions begins your Dyno/E-tuning testing and it is found that your vehicle is not mechanically sound and it becomes necessary to pull the vehicle off of the dyno and/or discontinue a remote or E-tuning session, then your non-refundable dyno deposit will be forfeit (not applied toward the tune) and you (the undersigned customer) will be responsible for the complete cost of the testing/tuning. If you have been assigned a tuning date and are absent from your specified appointment for ANY reason and have failed to provide a 7 day notice PRIOR to your scheduled appointment, then your non-refundable dyno deposit will be forfeit. When you are rescheduled, you will be responsible for the complete cost of the testing/tuning.
