This agreement made on \_\_\_\_\_ by and between Partech LED Ltd, a corporation incorporated in the republic of Ireland , herein after referred to as "Manufacturer", and \_\_\_\_\_ hereinafter referred to as "Buyer", is as follows:

1. **PRICING PROGRAMS** - Products will be ordered by Buyer and sold by Manufacturer at discounted MSRP prices outlined in the MIGRO ARAY wholesale price list.
2. **MINIMUM ADVERTISED PRICE (MAP)** - Buyer agrees to not display or advertise MIGRO products at prices below the listed MSRP. The Manufacturer may terminate the partnership with the Buyer if this policy is violated.
3. **PAYMENT AND SHIPPING** - Buyer shall pay a 25% non refundable deposit to start the order and 100% for products two weeks prior to shipping. Buyer agrees to pay for all shipping costs at the time of purchase.
4. **BRANDING** - If buyer is directly reselling or installing a MIGRO product, the MIGRO brand must be present. The buyer cannot use his or her own brand name on any MIGRO products. The buyer cannot claim a MIGRO product under another brand.
5. **COPYRIGHT** - All MIGRO marketing materials including product photos, graphics, and logos are to be used only for the sales of MIGRO products or promotion of the MIGRO brand. No part of the materials can be used or copied for other purposes without written permission from MIGRO.
6. **SALES CHANNELS** - Buyer can resell MIGRO products through all sales channels except through third party ecommerce platforms including but not limited Amazon, Ebay, and Craigslist.
7. **PRODUCT RETURNS AND WARRANTIES** - All products may be returned by Buyer to Manufacturer for a full refund within 30 days after purchase. Returns must be in new resell condition. Buyer is responsible for all shipping costs of returning non-defective products. Defective products may be replaced by Manufacturer within one year after purchase. Manufacturer makes no other warranties, whether express or implied; and shall be limited to the purchase price of products sold.
8. **NON-DISCLOSURE** - Any information that the Manufacturer shares with the Buyer pertaining to the partnership will be regarded as Confidential Information, this includes but is not limited to Manufacturer's retail program, pricing, business plans, and products in development. Buyer agrees to use its best efforts to prevent and protect the Confidential Information from disclosure to any third parties.
