

You may request a tax receipt in January. We kindly ask that you pick up unsold items outside of our regular scheduled consigning hours.

You may pick up money anytime during regularly scheduled business hours: Wednesday-Saturday 10 am-5 pm. Money is available on your account for 4 months. Any money left unclaimed after 4 months will be forfeited to Closet Encore, LLC. Should you request a check, a \$2.00 fee will be deducted from your account. You must provide your most current information and address. There is a fee added to the merchandise that is paid for by the purchasing customer.
