Birth and Growth of EU

1991	Maastricht Treaty created the European Union and set the goal of economic and monetary union. Maastricht sought to "deepen" the union recognising also that the union would "widen", not least in the light of the end of the Cold War.

Although the EU and most of it member states lack any confessional basis to their political structures, it should be noted that, in addition to the establishment status of the CofE, the Preamble of Ireland's Constitution opens "In the Name of the Most Holy Trinity, from Whom is all authority and to Whom, as our final end, all actions both of men and States must be referred" while the Roman Catholic Church is effectively established by the constitution of Malta.
