#### I. Introduction

TheInsoleStore.com is proud to offer exclusive discounts for approved business customers who place or plan to place volume orders through TheInsoleStore.com. Please read below to determine if you should apply, how to apply, and how our program works if you are approved for the program.

#### II. Who Should Apply

TheInsoleStore.com Volume Discount Program is designed for businesses and entities that intend to purchase products for use, not for resale. TheInsoleStore.com does not approve customers who intend to purchase products for resale, such as Amazon sellers, distribution firms, or independent retailers.

#### III. How Do I Apply

Please complete all information on page 3 of this application. You must prove that you are ordering on behalf of a registered business, government program, or other such entity. You must prove that you are authorized to submit this application and to place purchase orders on behalf of your business/entity. You must also state your intent for purchasing.

Upon receipt of your application, please allow 5-10 business days for processing and approval.

#### IV. Discounts

As of November 1st, 2020, TheInsoleStore.com offers the following discount opportunities:

- For orders of 10-29 products: 15% off listed price
- For orders of 30-99 products: 20% off listed price
- For orders of 100+ products: 25% off listed price

Orders must be either placed directly on TheInsoleStore.com while using your approved Volume Discount Program account or placed directly with an authorized Volume Discount Program sales representative. Orders placed using guest checkout, a different account, or with a sales representative not authorized to assist with Volume Discount Program orders will not receive these discounts.

V. Product Availability & Order Lead Times

There may be certain limitations on the quantities of products which may be purchased directly on our website. Should you wish to place an order for a quantity greater than what our website allows, you should contact a Volume Discount Program sales representative to assist with placing your order.

Additionally, depending on the products and quantities ordered, TheInsoleStore.com may require a lead time to prepare your order. As such, we do not guarantee same-day shipment for orders placed using our Volume Discount Program. We are always happy to provide an estimated lead time prior to finalization of your order.

VI. Payment Terms

All Volume Discount Program orders must be paid for using either credit card or PayPal. At this time, we are unable to accept payment by ACH, cash, check, EFT, wire transfer, or any other methods of payment. Your order must be paid in full prior to your order being prepared for shipment. We do not extend payment terms to any Volume Discount Program customer.

VII. Returns

TheInsoleStore.com does not allow the return of any merchandise purchased using our Volume Discount Program unless explicitly approved in advance by a member of our Volume Discount Program team. You must receive a Return Authorization Number (RAN) prior to the return of all or part of your order. Returns received without approval or without a RAN will not be accepted.

TheInsoleStore.com will replace merchandise that is received defective or damaged upon shipment delivery. You must contact us within 7 days of shipment delivery to arrange replacement of such merchandise. TheInsoleStore.com will not replace or refund any merchandise after use or wear.

If you would like to obtain a product sample prior to finalizing your order, we would be happy to assist with this.

VIII. Exclusions

Certain other exclusions apply to orders placed using our Volume Discount Program:

- a. Merchandise from select brands are ineligible for any discount opportunities, including orders placed using our Volume Discount Program.
- b. Shipment of your order will be made using a carrier of our choice and will include signature delivery confirmation.
