





The Controlco five-year warranty does not cover general wear and tear that will occur to the product over its useful life. Hazardous substances are suitable for either short term, long term or not suitable at all for storing/using in products made from polyethylene. It is the user's responsibility to ensure suitable chemicals are used with your Controlco secondary containment product. If a product is damaged due to incorrect use, or use with incompatible substances, the warranty is null and void.
