DEED OF GUARANTEE AND INDEMNITY

In consideration of Anyware Computer Accessories NZ Ltd at the request of

- supply or continue to supply goods or services to (Customer) as the Purchaser ("Purchaser"), or
- provide credit to the Purchaser; or
- grant an indulgence outside Anyware Computer Accessories NZ Ltd's agreed credit terms,

The Guarantor hereby :

1. Agrees to guarantee to Anyware Computer Accessories NZ Ltd the due and punctual payment of all money presently owing or any money that may be owing in the future by the Purchaser, in respect of the cost of goods or services supplied by Anyware Computer Accessories NZ Ltd to the Purchaser and any other sums payable by the Purchaser to Anyware Computer Accessories NZ Ltd pursuant to Anyware Computer Accessories NZ Ltd' Terms and Conditions of Trade (hereinafter collectively called "guaranteed money").

2. Agrees as a separate severable and additional covenant and obligation to indemnify and keep indemnified Anyware Computer Accessories NZ Ltd from and against all losses, costs, charges and expenses whatsoever that Anyware Computer Accessories NZ Ltd may suffer or incur in relation to the supply of goods or services to the Purchaser and further agrees that each of the provisions hereinafter contained that applies or is capable of application to this Deed when it is construed as an indemnity will apply to the indemnity hereby given by the Guarantor.

3. Covenants, acknowledges and agrees as follows:

(a) The Guarantee hereby given is a continuing guarantee, the indemnity hereby given is a continuing indemnity and neither this Deed nor the said guarantee nor the said indemnity will be discharged in any way or be considered or deemed to be discharged in any way by any payment to Anyware Computer Accessories NZ Ltd other than the payment to and acceptance by Anyware Computer Accessories NZ Ltd of the whole of the guaranteed money.

(b) Notwithstanding that as between the Guarantor and the Purchaser the position of the Guarantor is that of surety only nevertheless as between

(c) the Guarantor and Anyware Computer Accessories NZ Ltd, the Guarantor is liable hereunder as a principal and as a primary debtor for the payment of the guaranteed money.

(d) This Deed is valid and enforceable against the Guarantor and the liability hereunder of the Guarantor continues and may be enforced by Company notwithstanding:

(i) that no steps or proceedings have been taken against the Purchaser;

- (ii) any indulgence or extension of time granted by Company to the Purchaser;
- (iii) the death or bankruptcy or winding up of the Purchaser;
- (iv) that payment of the guaranteed money by the Purchaser cannot be legally enforced against the Purchaser.
- (e) The Guarantor will not compete with Anyware Computer Accessories NZ Ltd for any dividend or distribution in the event of the Purchaser being declared bankrupt, going into liquidation or being wound up or entering any deed or scheme of arrangement or assignment or composition in respect of its affairs or its assets and liabilities.

4. The Guarantor hereby acknowledges having given its consent to Anyware Computer Accessories NZ Ltd to obtain from a credit reporting agency a consumer credit report containing information about it for the purpose of Anyware Computer Accessories NZ Ltd assessing whether to accept the Guarantor as a guarantor for credit that may be applied for by the Purchaser.

5. The term "Anyware Computer Accessories NZ Ltd" includes its successors and assigns and the terms "Purchaser" and "Guarantor" include their respective executors, administrators and successors.

6. In this Deed the singular includes the plural and if there is more than one Guarantor to this Guarantee their obligations are joint and several.
