This agreement is not for the benefit of any third party and shall not be considered to grant any right or remedy to any third party.

The validity, construction and performance of this agreement is and shall be governed by the laws of the state of California. The forum for the resolution of any dispute related to this agreement, whether in tort, contract or in equity, are based upon federal or state statute or regulation shall be Los Angeles, California. Both parties acknowledge that failure of seller to perform will cause Buyer to incur costs not contemplated by this agreement, and that the exact amount of such costs are extremely difficult and impracticable to fix.
