It is not cancellable prior to completion date. Terms are F.O.B Seller's warehouse in Los Angeles. Payment of goods including shipping is due prior goods leaving Seller's warehouse. For buyers using a factor, order will be submitted to their factor for approval prior leaving Seller's warehouse. Shipping point and title passes to buyer upon delivery to carrier. The acceptance of shipment by a common carrier or licensed public truckman shall constitute delivery.

This agreement is not for the benefit of any third party and shall not be considered to grant any right or remedy to any third party.

The validity, construction and performance of this agreement is and shall be governed by the laws of the state of California. The forum for the resolution of any dispute related to this agreement, whether in tort, contract or in equity, are based upon federal or state statute or regulation shall be Los Angeles, California.

Both parties acknowledge that failure of seller to perform will cause Buyer to incur costs not contemplated by this agreement, and that the exact amount of such costs are extremely difficult and impracticable to fix. Seller shall therefore not be liable for any consequential damages whatsoever.

Sellers's goal is to provide sample and production items that are as close as possible. Buyer need to be aware that Sample items have not gone through complete and comprehensive fitting process which will be done during production process to ensure a proper fit. This stage may also require or necessitate the addition or deletion of fastenings on a garment, such as button, clasps, ties or other closures.

Sample items and production items are fabricated using different manufacturing and production processes. These differences in process result in variations between sample and actual production pieces being shipped to Seller. Variation of approximately +/-15% in the following product characteristics Fabric Weight, Color Saturation, Color Hue are therefore acceptable.
