## Terms and Conditions

The terms and conditions described in this section are for the Casavogue Designer program. These terms and conditions may be changed at any time without notice to registered members. Any changes to the terms and conditions of this program will be made available in the Casavogue Designer program section of the website and will be effective as of the date of posting.

Casavogue reserves the right to contact members directly through the contact information provided by the member at any time regarding changes to the program or their membership.

**Eligibility Requirements** 

An accredited professional designer will be eligible to participate in the Casavogue Designer Program upon approval by

Casavogue following the submission of the following documents:

- A completed and signed application form;
- A business card indicating profession, company name, email and website and; a) A copy of a business license or resale certificate that proves the existence of a design business (with an additional signed resale certificate for each province where tax exemption is requested) or; b) A copy of a valid membership card in one of the following professional organizations
- APDIQ (Association professionnelle des designers d'intérieur du Québec) ;
- ARIDO (Association of Registered Interior Designers of Ontario);
- ARIDNB (Association of Registered Interior Designers of New Brunswick);
- CDECA (Decorators Association of Canada);
- PSC (Property Development Professionals of Canada);
- IDA (Interior Designers of Alberta);
- IDAS (Interior Designers Association of Saskatchewan);
- IDIBC (Interior Designers Institute of British Columbia);
- IDNS (Interior Designers of Nova Scotia);
- PIDIM (Manitoba Institute of Interior Designers);
- Other associations accepted by the company's management.

## Membership

- Individual professional designers may apply for membership. An application cannot be submitted on behalf of a design firm or entity. Individuals employed by the same firm must apply individually; the firm itself may not become a member;
- Membership is non-transferable;
- The designer is responsible for notifying Casavogue of any changes to his or her file;
- Designer may update contact information by emailing **info@casavogue.ca**; Members may cancel their membership at any time by emailing **info@casavogue.ca**; Casavogue employees are not eligible for the program.

## Membership Misuse

Misuse of membership may result in termination of membership. Casavogue reserves the right to re-evaluate and terminate a member's eligibility if Casavogue believes the designer is not complying with the terms of this agreement. Casavogue will notify the program member of the termination of membership.

## Discount

- Members will receive an incentive of 10% of the amount of items at list price before tax, purchased in store or 5% on promotional items;
- The incentive is non-negotiable;
- Incentive does not apply to gift cards, services, shipping and handling or other fees; or to clearance items
- The incentive applies when the designer recommends Casavogue to a new customer;
- Return and/or cancelled purchases will be deducted from the member's profile;
- The incentive cannot be applied to purchases made before joining the program;
- Incentive is paid by check after balance paid and purchases delivered.

Purchase and payment conditions
