

MATTRESS HUNTERS BEDFRAME WARRANTY

1-YEAR LIMITED WARRANTY

This Warranty page outlines the terms and conditions of the warranty provided by Matters Hunters on behalf of the Manufacturer, SouthBay International. Please carefully read and understand the following warranty information before making a purchase. By purchasing a product from the Vendor, you agree to be bound by the terms and conditions outlined on this Page.

Mattress Hunters warrant that this product is free from defects in workmanship, materials, and construction. This product is subject to specific limitations and expectations subsequently set forth in the limited warranty. The bed frame is warranted to be free from defective materials or workmanship for 1 year from the date of purchase, under normal care and use.

If the product develops defects for reasons other than misuse or neglect within the limited warranty period, Mattress Hunters guarantee that this bed frame will be replaced at our option, without cost to you. But it should be deemed defective because of faulty workmanship or structural defects, excluding the specific limitations contained herein.

In the event identical materials are not available to be used in the replacement for the product, we (SouthBay), the manufacturer, reserve the right to substitute other materials of equal or greater quality. The customer is responsible for returning the product to the manufacturer. All transportation costs are the responsibility of the purchaser.

This limited warranty is valid only to the original purchaser of the product. You must provide proof of purchase for any limited warranty claim. Warranties are made only to the original retail purchaser and do not cover merchandise purchased or used, secondhand, or distressed. Proof of purchase and an image of the defect is required when placing a claim. A receipt or canceled check can serve as proof of purchase.

All warranties contained herein shall not apply if the product has been physically damaged, burned, cut, or is abnormally soiled or unsanitary. The manufacturer reserves the right to refuse service when the product is found to be stained, soiled, in unsanitary conditions, or when product failure is due to cause of misuse or abuse. These warranties do not cover normal wear and tear.

The limited warranty does not apply under the following conditions and circumstances:

- When product failure is due to causes other than defective workmanship or materials.
- If the product is showing normal wear and tear.
- If this product is used for commercial purposes.

- If the purchaser does not produce proof of purchase.

SAFETY INFORMATION

Only use this bed frame for its intended purpose as a decorative bedframe and/or a mattress foundation with the following considerations:

- Exceeding this weight restriction could damage the bed and/or cause injury and will void the warranty. Weight Capacity is 661 pounds, including the mattress and user(s).
- Mattresses may move or shift on the bedframe—use caution.
- Do not allow children or pets to play on, around, or under the bed frame.

USAGE AND SUPERVISION

Supervision is required for use by children, animals, convalescents, or disabled persons. Immediately dispose of all packing materials as they may pose a risk to small children and pets. To avoid injury, do not allow children or small pets to play on, around, or under the bed frame.

WEIGHT CAPACITY

The recommended weight capacity for the express bedframe is 661 pounds, which is calculated to include the weight of the mattress and users. The bedframe will support the recommended weight limits if distributed evenly across the bedframe. This product is not designed to support the total maximum weight limit in an isolated section such as the head or foot of the bed frame alone.

TIPPING WARNING

Placing weight at the edge may cause the bed frame to tip.

EXCEEDING THE WEIGHT CAPACITY OR VIOLATING ANY OF THE SAFETY INFORMATION WILL VOID THE WARRANTY AND MAY RESULT IN DAMAGE OR INJURY. All implied warranties shall be limited to the period of this limited warranty unless otherwise required by applicable federal or state law. Some states do not allow limitations on how long a limited warranty lasts, so consequently, the limitations may not apply.
