PRO FLY-TRAP water-soluble sachets dissolve in the water in the PRO FLY-TRAP to attract most common species of nuisance flies including house flies (Musca domestica), flesh flies (Sarcophaga spp), blow flies (Calliphoridae family), lesser house flies (Fannia canicularis) and horse flies (Fannia canicularis) and horse flies (Tabanidae family).

DIRECTIONS FOR USE

REALLY SERIOUS PRO FLY-TRAP GRANULES are designed for use only with the REALLY SERIOUS PRO FLY-TRAPS. LARGE or MEDILIM



It typically takes 2-5 days depending upon the temperature for the PRO FLY-TRAP GRANULES to be fully activated and reach maximum effectiveness. The PRO FLY-TRAP will remain effective for 30 - 60 days. depending on light, temperature, wind, position, and other weather conditions.

Once activated, the PRO FLY-TRAP must be placed outside around areas of livestock housing, waste bins or buildings in general. It will develop a strong, characteristic odour that is highly attractive to flies, Consequently, PRO FLY-TRAP is not suitable for placement in close proximity to people. The goal is to build a protective fly interception zone by spacing the traps 10 - 15 metres apart around the areas where flies are a nuisance.

Where possible, place the PRO FLY-TRAP at a height of 150 cm above the ground.

- PRO FLY-TRAP MEDIUM cover about 100-150 m². • FPRO FLY-TRAP - LARGE cover about 200-300 m².
- Do not let the liquid inside the PRO FLY-TRAP evaporate completely. Add water from time to time and top up to the initial level. PRO FLY-TRAPS must be placed away from sources that can interfere with their attractive power (e.g. fertilizers, sewage pits, organic fermentation sources).

After 30-60 days, safely dispose of the contents of the PRO FLY-TRAP and reactivate the Trap with PRO FLY-TRAP GRANULES and fresh water as detailed above.
