DIRECTIONS FOR USE

RESTRAINT: DO NOT place pellets in heaps.

CROPS/SITUATION	PEST	RATE	CRITICAL COMMENTS
Seedlings and mature crops of vegetables and flowers, potted plants and all areas where snails and slugs congregate.	Snails, slugs	5 g/m ²	<p>When applying to crops, ensure pellets do not become lodged in plant foliage. Scatter pellets on the soil around or near the plants to be protected. Scatter pellets after rain, or water area to be treated prior to application. Apply bait evenly. Reapply as the bait is consumed or at least every 2 weeks while slugs and/or snails continue to be a problem, or following heavy watering or periods of heavy rain.</p> <p>All likely areas of infestation should be treated, especially the perimeter of vegetable and flower gardens, because these pests move into planted areas from surrounding daytime refuges. Evening is the best time to apply the bait as slugs and snails travel and feed mostly at night or in the early morning.</p> <p><u>Vegetables, flowers and berry fruits</u> Scatter the bait around the perimeter of the plot and also on the soil around or near the plants.</p> <p><u>Ornamental shrubs and seedling fruit and citrus trees</u> Scatter the bait in a 15 cm diameter circular band around the base of the plants and also around the perimeter of the plot.</p> <p><u>Established fruit and citrus trees</u> Scatter the bait around the base of the trees to intercept snails and slugs travelling to the trunks.</p>

GENERAL INSTRUCTIONS

Protect-us Mineral SNAIL AND SLUG KILLER is a patented low hazard formulation that is highly effective in the control of snails and slugs. When the snails or slugs consume Protect-us, they typically lose their appetite and crawl off to seek shelter and protection where they die. Protect-us protects all plants by effectively killing snails and slugs. Use around seedlings, potted plants, vegetables, crop plants, perennials and any other plants affected by snails or slugs.

PROTECTION OF LIVESTOCK AND DOMESTIC ANIMALS

DO NOT place in locations which are accessible to domestic animals, livestock or birds.

Lock in a safe place preventing access of children, animals, poultry or ducks. Keep away from domestic pets. Keep away from dogs. Dogs may find this bait attractive. If domestic pets eat Protect-us Mineral Snail and Slug Killer contact a veterinarian immediately, as the consumption of large quantities may be toxic. The active ingredient in this product is elemental iron. This product DOES NOT contain metaldehyde or methiocarb. Clean up spilled pellets after filling applicator.
