
Included Components

- A. Hardware Packet Z, with Instructions (Not Shown)
- B. Axis Cast Glass QTY: 6
- C. Cable Grippers QTY: 6
- D. Cable QTY: 6
- E. Canopy with cover plates and LED drivers Installed

Required Tools

- 1. 9/64" Allen Hex Key (Provided)
- 2. Flat Head and Phillips screw driver (not provided)
- 3. Wire cutters/strippers (not provided)
- 4. Measuring Tape (not provided)



Fixture Glass Install Instructions

Step 1: Ensure Aluminum Glass Bracket is install on Glass as shown above with Silicon washer properly seated.

Step 2: Remove small access panel on fixture body using slotted drive screw driver. This will expose the glass retention screw.

Step 3: Orient glass as shown, so aluminum faces of glass bracket are facing up and down. Threaded hole on glass bracket will be aligned with retention screw when properly oriented.

Step 4: Insert Glass assembly into end of Fixture Body Tube. Look through Access panel to align retention screw and thread into hole on glass bracket.

Step 5: Tighten retention screw with provided 9/64" Allen key so glass is secure and hanging straight.

Note: Take care not to over-tighten screw

Assembly Instructions

Step 1: Remove Canopy cover plate from the faceplate by removing two 4-40 flat head screws using Phillips head screw driver. Mount Canopy (E) to ceiling using the appropriate Hardware Packet (A) and included instructions.


Step 2: Make Electrical Connections from the building to the Drivers inside of Canopy using the wire nuts provided. Replace Cover plate.

HARDWARE PACKET Z: MOUNTS TO BUILDING STRUCTURE




Step 3: Cables (D) and Cable Grippers (C) are marked by a numbered tag. Each Cable (D) will be inserted into the Cable Gripper (C) marked with the same number.

Step 4: After locating the corresponding Cable (D) and Cable gripper (C), unscrew the Cable Gripper Cap (Ci). Thread the Cable (D) through the Cap (Ci) and into the Gripper Body (Cii). Adjust fixture height by pushing or pulling Cable through Gripper Body while depressing threaded plunger at top of Gripper.



CAUTION: CABLES ARE
CONDUCTIVE. DO NOT POWER
FIXTURE WHILE CABLES ARE IN
CONTACT WITH ANY CONDUCTIVE
SURFACE. THIS INCLUDES HAVING
THE CABLE PROTRUDE THROUGH

OF THE LIGHT FIXTURE.

Step 5: Use a measuring tape and level to ensure the fixture is hanging at the desired distance from the Canopy. Reference table 1 for the recommended cable lengths for the fixture. When desired height is attained cut excess Cable flush with Gripper Body. Thread Cable Gripper Cap back onto Body.



Set cable 1 at the height you want the fixture at, then size the rest of the cables based on the offset from the table.


