Privacy Policy

- 1. This Privacy Policy details how Bana Industries Pty Ltd handles, collects, discloses and uses your personal information.
- 2. Please note that all words and terms defined in our Terms and Conditions carry the same meaning in this Privacy Policy. Please also note that we may update this Privacy Policy from time to time without prior warning.
- 3. By purchasing a product from us, creating an account and/or engaging our services, you agree to the collection, disclosure and management of your personal information as prescribed in this Privacy Policy which is guided by the *Privacy Act* 1988 (Cth) (**The Privacy Act**), in particular, the Australian Privacy Principles as contained in this legislation.
- 4. The Privacy Act defines 'personal information' as information or an opinion about an identified individual, or an individual who is reasonably identifiable. This means that 'personal information' has a broad scope and encompasses information such as, but not limited to:
 - ! your full name:

 - ! IP addresses and cookie data.
- 5. We collect, use and/or store your personal information for a variety of reasons, including but not limited to:

 - ! our business is sold or partly-sold to a third party (including our assets and records); or
 - ! consent has been provided.

Should you choose to receive such communications from us, you reserve the right to opt out at any time.

We will promptly acknowledge your e-mail, commence investigation, and will get back to you within 30 days from when your e-mail was first sent.
