Terms and Conditions**

The Following Terms and Conditions govern the purchase and installation of a Vehicle Wrap, Accent Wrap, Vehicle Graphics, Spot Graphics, PPF, PPF Wraps, or any other terms used to describe the act of wrapping a personal or commercial vehicle by Accelerated Graphics, LLC. It is required that all information pertaining to your vehicle's condition be provided prior to delivery of the vehicle for installation.

**Limited Warranty**

Accelerated Graphics, LLC provides a 120-Day Limited Warranty for all material defects or installation errors, including Vinyl Lifting, Peelings, Wrinkles or Bubbling. Any Damages from Road Hazard contact, Accidents, or General Normal Wear and tear of the Vinyl used. Limited Warranty does not cover PPF or PPF Wraps.

This Limited Warranty does NOT cover damages to a Vehicle Wrap, PPF or PPF Wraps caused by improper vehicle care, including use of ANY type of Automatic vehicle washing stations (car-wash stations where unknown soaps and/or water are applied under pressure), improper chemical cleaning agents and pressure washing, or ANY application of liquid deemed detrimental to the integrity of the wrap.

All Claims under the Limited Warranty are subject to inspection and approval by Accelerated Graphics, LLC Installation Professionals. Repairs done under this warranty are performed at the discretion of Accelerated Graphics, LLC. Accelerated Graphics, LLC has final approval on whether the repairs or re-installation of the vehicle wrap, PPF or PPF Wraps are to be performed on your vehicle.

If ANYONE other than an Accelerated Graphics, LLC installer has made an attempt to alter, remove, re-install or repair any work performed, The Limited Warranty is Null and Void.

Limited Warranty Claims are to be submitted to Accelerated Graphics, LLC as soon as issues are found at [Sales@AcceleratedGFX.com](mailto:Sales@AcceleratedGFX.com). Accelerated Graphics, LLC will make every effort to prioritize Approved Limited Warranty Claims, however, please allow up to 30 days after notification for warranty work to be completed.

**Disassembly and Reassembly of vehicle components**

In order to properly install your vehicle wrap, PPF or PPF Wrap, Your vehicle may require limited disassembly. Body Panels, Doors, Hoods, Trunks, interior trim panels, or other components may have to be taken off.

During disassembly, parts will be removed and reinstalled in the same manner and condition as when they were originally on the vehicle. Although we take extra care to ensure that every part is removed in the best possible condition, clips, tabs, alignment pins and other parts can break or slightly warp.

In the event of damage during disassembly or reassembly, Accelerated Graphics, LLC will take the necessary measures to repair any parts affected or damaged. In some cases, at our discretion,

Accelerated Graphics, LLC may choose to replace pieces, clips or tabs that might become damaged or affected by removal and re-installation. Replacement and repairs are at the sole discretion of Accelerated Graphics, LLC.

Several newer model cars have electronic sensors or devices that can tell if body parts have been removed and reinstalled. In some occasions, this can trigger a check engine light or code. Accelerated Graphics, LLC is NOT responsible for clearing or resetting any codes or indicator lights that may have been caused as a result of the removal or reinstallation of parts or panels. Accelerated Graphics, LLC is not equipped to clear these codes. Customer waives liability of clearing or resetting codes by signing hereunder.

#### **Proper Care for Vehicle Wraps, PPF or PPF Wraps.**

Proper care for your vehicle wrap, PPF or PPF Wrap is important to maintain the quality of the material throughout its lifespan. Accelerated Graphics, LLC recommends the following to care for your Vehicle Wrap, PPF or PPF Wraps.

- I. Only hand-wash your vehicle using a Ph Neutral soap.
- II. Do NOT use Car Wash soaps that contain waxes or other detailing chemicals mixed in them.
- III. Do NOT Pressure-Wash your wraps. This WILL damage your product.
- IV. Do NOT use degreasers.
- V. Dry vehicle using a CLEAN Microfiber Towel or Soft cloth rag.
- VI. Do NOT use automatic car wash.

#### **For Best Results.**

Vehicle wraps, PPF and PPF Wraps are recommended on vehicles less than 5 years old with original factory paint. Scratches, paint imperfections, dents, dings, clear coat failure, paint chips, gouges, paint flaking, surface oxidation and other "surface imperfections" could be quite noticeable after wrapping and could lead to premature failure of vinyl, PPF or PPF Wrap Adhesives.

Accelerated Graphics, LLC recommends that all surfaces be in good condition prior to wrapping.

#### **Disclaimer**

Accelerated Graphics, LLC CANNOT guarantee that a vehicle wrap, PPF or PPF Wrap will not damage a vehicle's paint job and disclaims all liability for paint damage caused by the installation or removal of a vehicle wrap, PPF or PPF Wrap. By wrapping your vehicle, you waive all claims to paint damages that may be caused as a result of the installation or removal of the vehicle wrap, PPF or PPF Wrap.

Accelerated Graphics, LLC is also not responsible for the results from removal of vehicle wraps, PPF or PPF Wraps that were NOT installed with us.

If for ANY reason you believe that your vehicle's paint could be damaged by a vehicle wrap, PPF or PPF Wrap, do not wrap it.

ANY pre-existing damage to your vehicle, including the paint or its other exterior elements, are not covered under the Limited Warranty described herein.

All other warranties, whether express or implied, including warranties of merchantability or fitness for a particular purpose or any other warranty as to performance, accuracy or completeness are specifically disclaimed.

Customer bears ALL risks relating to quality and performance of the goods provided. No oral or written statements or information provided by the company in connection with the purchase of a Vehicle Wrap, PPF or PPF Wrap from Accelerated Graphics, LLC, including but not limited to any statements regarding durability shall create any other warranty not specifically set forth in this limited warranty or in any way amend or modify this disclaimer.

### **Limitation of Liability**

Accelerated Graphics, LLC's liability shall be limited to direct damages **proven by Customer** to have been caused solely by Accelerated Graphics, LLC. In no event shall the liability for damages exceed the purchase price paid, if any, by the Customer hereunder. Accelerated Graphics, LLC excludes liability, whether based on contract, tort (including negligence), or other legal theory, for any damages to customer or other party except as set forth in the limited warranty stated herein, including but not limited to, punitive damages, special damages, indirect, incidental or consequential damages of any kind, loss of revenue or profits, loss of business or other financial loss arising out of or in connection with the sale, installation, maintenance, use, performance or failure of the goods or services. The exclusion of liability stated herein shall exist even though Accelerated Graphics, LLC or the customer has been advised of the possibility of such damages.

### **ALL SALES ARE FINAL – NO REFUNDS UNDER ANY CIRCUMSTANCES**

The customer agrees to our NO REFUND policy, subject to the sole and exclusive warranty agreements outlined within this document.

The customer understands and agrees that if there is a credit card charge-back, returned check or other occurrence which causes payment for their vehicle wrap, PPF or PPF Wrap to be returned after services are rendered, Accelerated Graphics, LLC will pursue civil action in a court of law to recover ANY and ALL amounts that were wrongfully charged back including fees for accounting services, bank and other transaction fees and Attorney fees if applicable.
