<b>Production Method:</b>	The immunizing peptide was produced by solid phase synthesis on a multipепptide synthesizer and purified by reverse-phase hplc chromatography. Purity was assessed by analytical hplc and the amino acid sequence confirmed by mass spectrometry analysis. This peptide was coupled to KLH prior to immunization into rabbits. New Zealand White rabbits were subcutaneously injected with KLH-coupled immunizing peptide every 4 weeks for 4 months. The sera from each animal was applied onto an agarose column to which the immunogen peptide was thio-linked. Antibody was eluted from the column with 0.1 M glycine, pH 2.5. Subsequently, the antibody solution was neutralized to pH 7.0 with saturated Tris.
<b>Antibody Amount:</b>	25 µg
<b>Antibody Concentration:</b>	1 mg/ml
<b>Lot Number:</b>	140724
<b>Storage Buffer:</b>	Phosphate buffered saline (PBS) pH7.4, 0.05% Thimerasol
<b>Storage Conditions and Stability:</b>	For long term storage, keep frozen at -40°C or lower. Stock solution can be kept at +4°C for more than 3 months. Avoid repeated freeze-thaw cycles.
