This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other nonhazardous ingredients are also possible.

This ASCC TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 (eight) hour working day for a 5 (five) day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 (four) times per day. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Potential Health Effects

Inhalation:

Section 4 – First Aid Measures

General Information:

Section 6: Accidental Release Measures

Accidental Release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage.
