# Introduction

Hi,

So first off, just wanted to say thanks again for picking up our Ultimate Will Package.

As you're aware of by now, making a Will is something that's extremely important to your estate - yet most Americans don't do it.

Why this is, I'm not 100% sure, but I think a lot of it comes from unawareness and legal complexity.

From the awareness standpoint, most just don't realize they need a Will.

"It all goes to my wife and kids anyway, so it doesn't matter" ...

Something that has some truth to it, but generally isn't that simple either.

On the other hand, everybody seems to think you need expensive attorneys to complete one - not the case.

Contrary to popular belief, creating a Will on your own is actually fairly easy, and that's what we're going to help you with today.

For the rest of this guide I'm going to be covering some main areas to consider, so you have the right ingredients in place, but our Will forms at the end will handle most of the heavy lifting for you after that.

Technically, you could just scroll down and pick out the right form, making a Will that way...

But I highly advise reading through our opening instructions first, as that'll help you navigate faster through the forms after that.

Anyway, enough of the small talk now, so let's get into the actual instructions.

# Instructions

For the rest of this process, it's merely a matter of choosing the right form and filling it out after that.

Fairly straightforward process, especially with the instructions we just covered, but when it comes to creating this Will...

I advise doing so in 3 main steps:

## **Step #1 - Writing down all your assets**

From my experience, it seems to make life easier when you write down all your assets first - then choose beneficiaries after that.

If you don't, you might overlook certain items, so before choosing beneficiaries...

I advise writing down all the assets you can think of, then start tying beneficiaries to all of them.

If it helps, here's a worksheet that'll allow you to do that:

## **Step #2 - Creating your Digital Worksheet**

Now that you've gotten all your assets in place, it usually works best if you take a second to complete your Digital Worksheet.

As I'm sure you can recall from earlier, this is the process of putting all "usernames" and "passwords" down for your executor.

Doing so makes their life easier, and even though it's not a "formal" part of your Will, it's something that should be included in your overall package (i.e. envelope).

### **Step #3 - Creating your actual Will**

Now that everything else is in place, it's time for you to create the actual Will.

We've included specific forms for specific situations, so please find the form that best suits your situation - and everything will be simple after that.

Again, once everything is completed, sign your Will in front of two witnesses...

Then store in an accessible location after that, and you've officially made your family's life easier (by creating a Will).
