SUPER-DRY SYSTEMS WARRANTY

I. Desiccant Air Dryers

The D Series desiccant air dryers are warranted on a prorated basis against defective materials and workmanship for a period of 10 years from the date of shipment. The warranty covers only the dryer housing, brackets and cover and does not include the clamp, internal grids, pressure gauges, fittings, and replacement cartridge.

I. In-Line Air Dryer

The ATD Series in-line air dryers are warranted against defective materials and workmanship for a period of 10 years from the date of shipment. The warranty covers only the caps and cylinder and does not include the drain cock, internal grids, and replacement cartridge.

II. Temperature and Humidity Gauge

The HGT Series temperature and humidity gauge are warranted against defective materials and workmanship for a period of 10 year from the date of shipment. The warranty covers the housing, the lexan glass and humiguide.

III. Compressed Air Filter and Water Separators

The F Series, FSD Series and SAF Series filters and separators are warranted against defective materials and workmanship for a period of 10 year from the date of shipment. The warranty does not include seals, gaskets, element, deflector and float drain.

IV. Electronic Timer Drain

The TD Series automatic timer drains are warranted against defective materials and workmanship for a period of 1 year from the date of shipment.

If such repairs are performed by the buyer without the written authorization of the seller, the seller will not assume any of the expenses in connection with such repairs and will immediately void any remaining warranty of the Goods. This warranty does not apply to defects resulting from shipping damage or misapplication. All warranty claims require a Return Materials Authorization (RMA) number from Super-Dry Systems Inc customer service department. The repair or replacement warranty herein set forth is the exclusive warranty given by the seller for its goods. This warranty is given in lieu of any or all warranties, whether written or oral, expressed, or implied. All implied warranties of merchantability or fitness for any particular purpose are hereby expressly excluded by seller. Seller neither assume, nor does it authorize any other person to assume on its behalf, any other liability in connection with the sale of its good.
