

2024 TOUR DE VERGE-WEEK 2 SWEEPSTAKES OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PREVIOUS PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. Eligibility: The 2024 TOUR DE VERGE-WEEK 2 Sweepstakes (“Sweepstakes”) is open only to legal U.S. residents and Globally to all residents who sign up at the online sweepstakes page and who are at least 18 years of age as of the date of entry. Employees of FX America Inc. 4. Sweepstakes Period: The “Sweepstakes Entry Period” begins at 12:00:01 A.M. Eastern Daylight Time on July 5, 2024 and ends at 11:59:59 P.M. EDT on July 14, 2024. Sponsor’s internal business computer will be the official clock of this Sweepstakes.

A valid entry must include your email address. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of FX America Inc. Limit one entry per person. Use of multiple e-mail addresses to enter is prohibited and will result in disqualification and all entries being void.

All entries become property of Sponsor and will not be acknowledged or returned. Entries that are late, incomplete, garbled/jumbled, illegible, or otherwise not in compliance with these Official Rules are void. Entries made by any other individual or any entity, and/or originating at any other website or e-mail address, including, without

limitation, commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes.
