WHEN POLICE DO THIS

1. REFUSE to ACT on your LEGITIMATE REQUESTS to intervene against obvious illegal acts by opposition workers.
2. Attempt to intervene AGAINST YOU in response to FALSE ACCUSATIONS from opposition workers.

YOU RESPOND:

1. "Let me remind you that Michigan Election Law requires your DUTY TO ACT in response to these violations."
2. "This is a false accusation intended to intimidate me and prevent my lawful participation as challenger."

WHEN THEY RESTRICT

1. Refuse/restrict your right to observe each aspect of the election process.
2. Restrict your legitimate actions in performing your Challenger role.

YOU RESPOND:

1. "I am a duly credentialed Election Challenger authorized by law to be present during the election process."

2. "By law, I am allowed to perform these actions in my role as Election Challenger."

WHEN THEY RESTRICT

3. Allow only participation by one political party in any election process.
4. Fail to provide equal "conveniences" based on political party.

YOU RESPOND:

3. "Your actions are in violation of MI election law requiring equal access to monitoring of this process."

MI Election Law (Act 116 of 1954, 168.730, 168.731, 168.733, 168.734)

4. "By law, you, as an election official, are required to provide me with equal conveniences to perform my duties as challenger. Failure to do so is a felony."

WHEN THEY OBSTRUCT

1. If after you cite MI Election Law, they continue to refuse you access or restrict your legitimate actions as an Election Challenger.
2. If they make light of these violations.

YOU RESPOND:

1. "I am trying to work with you within the law, but if you continue to obstruct my lawful participation, I will be forced to contact legal assistance and/or law enforcement."
2. "I want to make you aware that your actions may constitute felony violations that expose you to legal jeopardy."

WHEN THEY OBSTRUCT

3. An election official refuses to act upon a legitimate challenge.
4. An election official refuses to prevent intimidation of challenger.

YOU RESPOND:

3. "Because you have refused to act upon my legitimate challenge, I must now contact the Clerk, Legal Assistance, and Law Enforcement."

4. "As an election official you are required by law to protect me (as a challenger) from intimidation/threat."

WHEN THEY DECEIVE

1. Deceive by giving illegal, inaccurate instructions or demands.
2. Fraudulently accuse you of illegal or inappropriate behaviors.

YOU RESPOND:

1. **"Your action is an attempt to prevent my lawful participation as a challenger which is a felony under MI law."**

MI Election Law (Act 116 of 1954, 168.734)

2. **"I have behaved appropriately, and your false accusation is an attempt to intimidate me and prevent my lawful participation as a challenger. That is a felony under MI election law."**

WHEN THEY DECEIVE

3. Delay in correcting a situation that you have brought to their attention in hopes that you will forget about it.
4. Misrepresent any action they took in response to your challenge which results in no resolution; the problem persists.

YOU RESPOND:

3. **"I realize that you are busy, but MI election law stipulates that you act immediately upon any challenge."**

4. **"I believe that you have not fulfilled your legal obligation to correct this problem which exposes you to criminal prosecution unless corrected."**

- Introduce yourself to Precinct Chair
- Be orderly and respectful at all times
- Direct any challenge to Precinct Chair
- Follow all laws in effect
- Keep record of challenges
