# How long has alleged systemic election fraud been happening in Michigan?

In the Nov 2017 Detroit City Clerk Election, contender Gilchrist had an early lead on election day, and then a surge in absentee ballots put Janice Winfrey (Detroit City Clerk since 2005) into the lead to win by only 1,486 votes (1.51%).


In the Aug 2020 Primary Election for the Wayne County Prosecutor, contender Burton-Harris had a lead during the day from in-person voting, but then the reception of absentee ballots thrust incumbent Kym Worthy ahead to win.

In the Nov 6, 2018 MI election for Attorney General, Dana Nessel won by only about 115,000 votes (2.7%) against Tom Leonard. This election had over 4M total votes and used the voting machine computers for counting.


In the Nov 2020 General Election, Trump (President) and John James (US Senate Contender) had large leads on election day, then a late surge in absentee ballots caused them to lose.





## Evidence of Internet Connection Capabilities in the Absentee Voter Counting Board (AVCB) Network







## Michigan Election Data Statistical Impossibilities



Statistically impossible jumps in the Biden vote counts really did occur in the election results early on Nov 4, including one jump comprised of +141,257 votes for Biden with a probability of occurrence of 1 in  $10^{117}$ , impossible for an organic election.



Sudden injection of 384,733 ballots across 4 Michigan counties (Wayne, Oakland, Macomb, and Kent) early on Nov 4, 2020. However, in a timespan of a few hours, the physical limitations of the election counting equipment at these locations would have allowed a maximum of 94,867 ballots to be counted, so 289,866 more ballots were "processed" than physically possible.
