WATERBASED URETHANE SEALER

Specco Green EZ™ Furniture Shield is a clear, medium solids, water-based urethane sealer designed for use over *Specco Green EZ™ Evolve Series Stains*. *Green EZ™ Furniture Shield* provides a semi-gloss sheen to the stained surface, provides excellent chemical and abrasion resistance when cured, and exhibits high resistance against re-hydrolysis (rewetting) upon water contact.

BENEFITS:

- Urethane formulation provides excellent stain and water resistance
- Improved hardness and abrasion resistance.
- V.O.C. compliant – less than 150 g/L (1.25 lb./gal)
- Ideal topcoat for wood-stained surfaces

DIRECTIONS FOR USE:

COVERAGE: Coverage rate will vary typically from 100-150 sq. ft./gallon with the absorption rate of the surface. **A test area is always recommended before application to ensure proper appearance aesthetics, film bond, as well as approximate coverage rate.**

SURFACE PREPARATION: All wood surfaces either stained or unstained should be clean and dry before sealer application.

APPLICATION: Apply *Green EZ™ Furniture Shield* using standard brushes and rollers working the sealer uniformly into the surface to the point of saturation, avoiding puddles and runs. For spray applications, a nylon or fine mesh type pre-filter can be applied to the intake hose to keep any polymer surface “skinning” particles (common to waterborne sealers exposed to open air) from entering the chamber and leading to a possible plugged sprayer tip. Drying time @ 75° F is approximately 1-2 hours. Protect the freshly sealed surface from dust, rain, condensation, and handling while drying. Tools may be cleaned with soap and water immediately following use.

CAUTIONS: Do not dilute or thin. Do not apply *Green EZ™ Furniture Shield* when the temperature is below 40° F. Do not apply to frozen or frost filled surfaces. Do not apply when rain is expected within twelve hours of the application.
