## **FURNITURE STRIPPER**

### **BIODEGRADABLE STRIPPING SOLUTION FOR FURNITURE RESTORATION**

**GreenEZ® Strip & Clean FURNITURE STRIPPER** is a heavy duty, yet non-hazardous, non-caustic, environmentally safe stripping solution formulated using soybean-based ingredients.

It is designed to remove adhesives, acrylics, paints, urethanes, varnishes, epoxies and related coatings from wood or metal surfaces.

GreenEZ Strip & Clean FURNITURE STRIPPER is composed to dry slowly which allows removal of multiple layers of coatings in one application.

### **BENEFITS:**

- Dissolves paints & coatings without damaging wood
- Semi-gelled viscosity allows application to vertical surfaces with minimal runoff and waste
- Slow dry time allows easy removal of multiple layers of coatings in only one application
- Water dispersible, low gumming formulation dissolves easily with Strip & Clean Finishing Cleaner for fast clean-up
- Contains no highly caustic compounds minimizing potential health hazard
- Solvent free formulation with minimal odor
- Formulated with biodegradable components

**COMPOSITION:** Soy based formulation with proprietary agents and rheology modifiers. Contains  $\underline{\mathbf{no}}$  methylene chloride or glycol ether components.

COVERAGE: Approximately 100-150 sq. ft. /  $\frac{1}{2}$  gallon. Actual square footage will depend on method of application as well as the type and age of the coating to be stripped, along with the corresponding thickness or number of layers involved in the removal process. Vertical applications typically range on the lower part of the specification when applied at typical  $\frac{1}{8}$ -inch thickness.

**DIRECTIONS FOR USE:** Applicator should read and understand all product technical data, label, and SDS information before using this product. User should test an area before application to determine suitability and results. Remove excessive coatings from the surface with a scraper or wire brush if they are already loose.

APPLICATION: *GreenEZ®* Strip & Clean FURNITURE STRIPPER should be shaken or lightly mixed before use to ensure uniformity of the cleaner.

Apply by use of chip brushes or disposable 3/8" nap rollers to all exposed areas. Strip & Clean FURNITURE STRIPPER is of medium viscosity and should be applied in an even layer approximately 1/8" thick.

Allow the material adequate time to penetrate and react with the coating which will aid surface softening and speed the removal process. Longer dwell times of 3-4 hours minimum offer the best results. Depending on coating type or thickness, overnight applications are sometimes helpful.

Strip & Clean FURNITURE STRIPPER will remain wet for several hours, so the user should refrain from any scraping until the treated surface has had time to loosen. The longer the exposure, the easier it will be to remove subsequent coatings.

If there is residual coating on the surface from the first stripping pass, the sequence should be repeated as necessary until all coatings are softened and remove.

**CLEAN-UP:** After the coating has softened sufficiently, the residue should be removed from the surface by use of flat scraper.

After removing the dissolved coating, the surface exhibits a thin film residue that is easily cleaned with *GreenEZ® Strip & Clean Finishing Cleaner*. This is applied by use of damp cloth rag and warm water damp rag rinse.

**CAUTIONS: Strip & Clean FURNITURE STRIPPER** should not be used on plastic, PVC, or rubber surfaces. For best results, do not apply when surfaces are below 40°F (4°C) or above 90°F (31°C).

Do not mix or dilute with any other materials. Keep from freezing. If the product dries on the surface on extended dwell times, simply apply a light second coat to reactivate it.
