**COMPOSITION:** Contains biodegradable components and alkaline builders, no phosphates or solvents.

#### COVERAGE / SUGGESTED DILUTION / USE RATIOS:

Approx. 100-150 sq. ft./gallon. Actual square footage will depend on dilution rate used as well as method of application. Dilute Green EZ™ Strip & Clean Finishing Cleaner 1:1 by volume with clean potable water for normal coatings, adhesive and mastic residual removal. For tougher, heavily deposited residuals use at full strength.

**APPLICATION:** Apply to stripped floor generously with brush and allow sufficient dwell time to loosen and dissolve all contaminants. On furniture, apply with a clean wet rag or sponge. Rinse with clean water when complete. Check for any remaining residue and repeat above steps if necessary.
