BEDBUGS: Disassemble beds and dust frames, joints, mattresses, tufts and seams, floors and baseboards.

OUTDOOR USE: EARWIGS, ANTS, CRICKETS, MILLIPEDES AND CENTIPEDES. Lightly coat areas where these pests are found or may hide including patios, windows, door frames and sills, outside of entrance ways, around foundations, and along ant trails. Repeat treatment as necessary.
