DIRECTIONS FOR USE:

Use bait to control the Norway rat (*Rattus norvegicus*) and roof rat (*Rattus rattus*) indoors and outdoors within 15 metres of buildings.

USE LIMITATIONS: Bait MUST be placed in tamper-resistant bait stations. This bait station may be used indoors and outdoors within 15 metres of buildings accessible to children, pets and non-target animals, consistent with all use restrictions and other requirements indicated on this label.
