Terms & Conditions

I, the lessee, agree to:

- 1) Notify St. Louis Strings of any change to the address, telephone number, email, credit card or bank account written on this agreement.
- 2) Bring the instrument, case, or bow to St. Louis Strings in the event a repair is needed.
- 3) Notify St. Louis Strings and file a police report in case of theft or loss.

If rental payments are current and continuous, St. Louis Strings agrees to:

- 1) Apply a <u>maximum 3 years</u> continuous rental payments to the purchase of current rental or qualifying step-up instrument.
- 2) Make all necessary repairs to instrument, case, or bow at no additional charge, EXCEPT for current standard rental outfit string replacement.

Additional terms:

- 1) Instrument outfit is rented for the chosen term and renews <u>automatically</u> unless the instrument is returned.
- 2) Rental fees are **not refundable**.
- 3) Rental credit is non-transferable, has no cash value and may not be redeemed for items other than step up instruments
- 4) Rental credit **expires 30 days** after instrument outfit is returned.
- 5) The lessee has no right to sell, sublease, mortgage, pawn, pledge, encumber, or otherwise dispose of the instrument outfit.
- 6) The instrument outfit is 100% owned by St. Louis Strings Violin Shop. By paying rent on the instrument outfit I gain no interest in the outfit.
- 7) The lessee does not have any legal obligation to pay rent for the subsequent periods if the property is returned in good condition.
- 8) Rental credit is **forfeited** if:
 - a. Continuous rental payments are not maintained.
 - b. The instrument is returned without an upgrade to, or purchase of, another instrument, thus ending the contract.
- 9) If rental payments are not kept current, a balance is owed and/or the lessee fails to return the instrument, St. Louis Strings or its representatives may, at its discretion:
 - a. Contact the client by telephone, email and U.S. Mail in an effort to collect the debt and/or St. Louis Strings' property.
 - b. Charge the lessee's "Payment Options" for rent overdue, collections fees and expenses.
 - c. Forward this account to a collection agency and/or credit bureaus.
 - d. Pick up the instrument from school, home or elsewhere, with or without prior notice to the lessee.
 - e. Pursue civil and felony criminal action to collect payment and/or St. Louis Strings property.
 - f. Cancel the rental contract.
