### Description

Jaz Garage Carpet is manufactured from polypropylene yarn with a latex backing. It is an interior floor covering. It comes in charcoal/grey/blue. Jaz is a smooth top carpet. The carpet should be glued down in accordance with our install guides.

It comes in 2m wide with an approx thickness of 5mm.

---

### Scope of use

Jaz Garage Carpet: • Is suitable for use as an interior floor covering • Is suitable for high traffic areas if installed to the install guide. • Is not suitable for outdoor use or areas exposed to sunlight • Is not suitable for use where the floor covering is exposed in interior areas of building where there are building code obligations under C3.4(b). Protection to fire Efl (EN14041) • Is not suitable for use in interior wet areas, i.e. on floors adjacent to sanitary fixtures or sanitary appliances, for E3 Internal Moisture control, i.e. leakage. (Note: this is not a reference to slip resistance) • Is not suitable for use on floors in food preparation areas (including residential/domestic kitchens) • Is not suitable for use on floors between adjoining tenancies, in

conjunction with other acoustic measures • Is not suitable for use in buildings with adjoining vertical tenancies in conjunction with other acoustic measures

## Conditions of use

Jaz Garage Carpet: • Must be installed according to Needlepunch Carpet Installation Guide. • Must be maintained according to Needlepunch Carpet Maintenance Guide. • Must use Dunlop Artificial Grass Adhesive OR an alternative glue recommended by a flooring preparations & glue specialist (e.g. Giltedge Industries, Look Floors).

## Building code performance clauses

### B2 Durability

B2.3.1

*Building elements* must, with only normal maintenance, continue to satisfy the performance requirements of this code for the lesser of the *specified intended life* of the *building*, if stated, or:

- (c) 5 years if: the building elements (including services, linings, renewable protective coatings, and fixtures) are easy to access and replace, and failure of those building elements to comply with the building code would be easily detected during normal use of the building.

## F2 Hazardous building materials

### F2.3.1

The quantities of gas, liquid, radiation or solid particles emitted by materials used in the *construction of buildings*, shall not give rise to harmful concentrations at the surface of the material where the material is exposed, or in the atmosphere of any space.
