



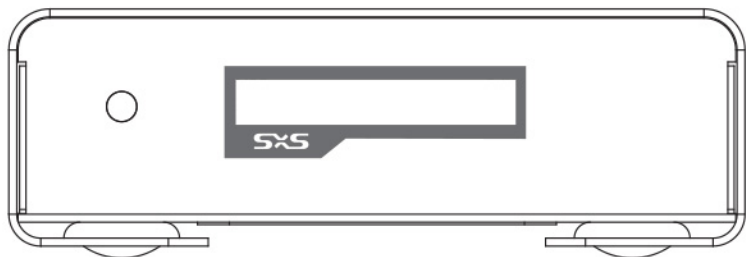

# Introduction

Thank you for purchasing Blackjet TX-1S!

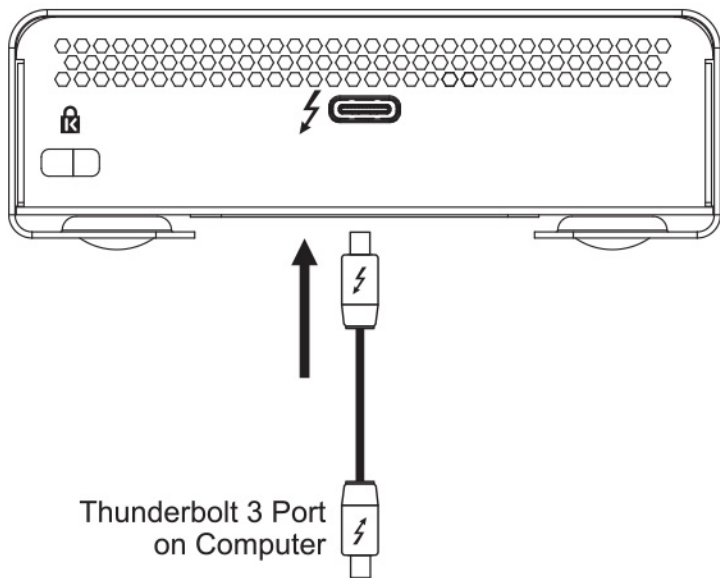
Blackjet TX-1S is designed to be integrated into your video workflow process.

Blackjet TX-1S boosts your video workflow by using Thunderbolt™ 3 technology with speeds of up to 40Gb/s. You can now quickly and easily ingest, edit, or back up your video contents from your media cards.

# Hardware Setup

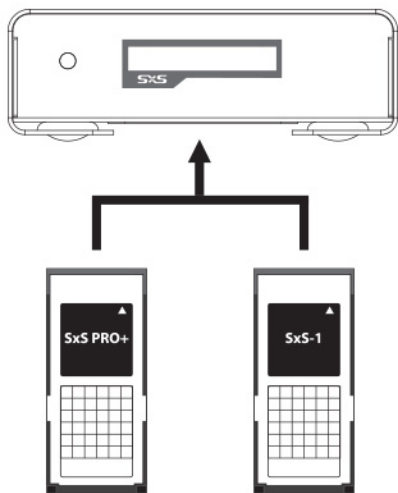
## Connecting to Computer

1. Connect one end of Thunderbolt 3 cable to Thunderbolt 3 port on the TX-1S unit.
2. Connect the other end of Thunderbolt 3 cable to Thunderbolt 3 port of computer.



# Inserting in your media card

1. Media Card should have label facing up and gold contacts facing back and towards card slot.
2. Hold the Media Card and gently insert the Media Card into card slot.
3. Push into the card slot until you feel the card lock into place.
4. The drive slot LED indicator will illuminate when the media card is detected.
5. The LED indicator will stay on until the media card is physically removed from card slot.



# Removing Drives

## Important Notes!

Please make sure there are no data activity from the media card, before ejecting or removing the media card. This will prevent any data loss or any errors.

## Ejecting Drive (macOS High Sierra +)

1. Locate the drive icon on your desktop you wish to eject.
2. Right click on the drive icon and select Eject.
3. The selected drive icon will disappear from the desktop.
4. Now you can safely remove the media card from Blackjet TX-1S.
5. The LED light will turn off when the media card is physically removed from the card slot.

## **Ejecting Drive (Windows 10)**

1. Locate the Safely Remove Hardware and Eject Media icon on bottom right of your desktop. Click the icon and a list of available drives and devices will appear.
2. Select and click on the drive you wish to eject.
3. The Safe to Remove Hardware notification window will pop-up.
4. Now you can safely remove the media card from Blackjet TX-1S.
5. Unplug Thunderbolt 3 cable and repeat Hardware Setup for next media card.

## **Caution!!**

Please make sure there are no data activity from the media card, before ejecting or removing the media card. This will prevent any data loss or any errors.

## **Make Back-up Copies**

We strongly recommend that you copy the files in the media cards to your computer first before attempting to view or make any changes to the files.

To help prevent the loss of your data, we highly recommend that you keep back-up copies of your data in separate storage locations. Keep one copy on your internal system hard drive and another copy on a second hard drive.
