4.1 Report by Chair

Craig Cameron welcomed everyone and thanked all the members for being here and for supporting us. He also thanked the board for all their work over the last year. He then thanked Ann and her staff. Craig noted it has been difficult to run a board during this challenging time and it has been difficult to be able to keep facilities open. He thanked staff for being dedicated and committed to the organization.

#### 4.2 Management Report

Ann thanked everyone for coming and braving the weather. In 2021 the exhibition galleries were closed for 6 months but the museum and gallery gift shops were able to remain open due to provincial regulations. Our online presence gave the public chances to look at exhibitions and experience many virtual art programs and tours. Ann then thanked all of our staff and visitors for keeping of us going while our doors were closed. The Restriction Exemption program allowed AHF to open all of our classes and facilities within certain capacities. Some highlights to note were: the community garden opened, the Dr. Anne Andersen Garden, heritage homes opened for tours and programs, archives continues to process records, Gallery continued to be flexible and changed the types of exhibitions they were able to show. Community art classes began again in a limited form; we were able to work with many new Indigenous artists. We look forward to a strong year ahead. Ann thanked everyone for coming and continuing to support our programs.



#### 4.3 Secretary-Treasurer/Auditor's Report

Presented by Suzanne Richford. The organization is in very good financial standing having navigated through covid exceptionally well. Suzanne made special reference to Natacha and Ann for this. 


