## Musée Héritage Museum Archives Terms & Conditions of Use

- 1. Permission for use is for **one-time use only**. Any subsequent use (including subsequent editions, paperback editions, foreign language editions, etc.) constitutes reuse and must be applied for in writing to the Arts and Heritage Foundation of St. Albert. Further fees may be levied at that time.
- All reproductions of photographs from the Musée Héritage Museum holdings must be credited to the Musée Héritage Museum, including Accession Number. In some cases, the name of the collection is required and will be noted at the time of acquiring the duplicate. Credit must be integrated into an image when images are transmitted digitally.
- 3. Images cannot be uploaded to any websites whatsoever. If user requires images on a website, the user must acquire special permission in writing from the Arts and Heritage Foundation of St. Albert.
- 4. Commercial fees are charged in addition to reproduction costs when an image is to be used for publication or commercial uses as described in Section 2.i of Musée Héritage Museum Collections and Archives Reproduction Policies and Procedures. Payment of fees do not exempt the user from including the appropriate credit.
- 5. No alterations whatsoever can be made to photographs, digital images, or any other media provided to the user, unless there is written consent from the Arts and Heritage Foundation of St. Albert. This includes not removing any watermarks and metadata on digital images.
- One complimentary copy of each publication should be sent to the Musée Héritage Museum.
- 7. The user may not reproduce or permit others to reproduce media obtained from the Arts and Heritage Foundation of St. Albert or facsimile of it without written permission of the Arts and Heritage Foundation of St. Albert. The Arts and Heritage Foundation of St. Albert reserves the right to allow duplicates to be only obtained from the Arts and Heritage Foundation of St. Albert.
- 8. In authorizing the publication of photographs or other media, the Arts and Heritage Foundation does not surrender its right to reproduce the media or grant permission for others to do so.
- All responsibility for possible copyright infringement and invasion of privacy arising from the use of reproduced media from the Arts and Heritage Foundation of St. Albert is assumed by the user.
