MIXING

Thoroughly mix the product with hard or soft water at the rate shown, then add wetter. The product should be applied only to vigorous vines growing under good conditions and capable of carrying an increased crop. This applies particularly to Muscat Gordo Blanco. As many factors affect yield of grapes, the use of FULL BLOOM FLOWER ENHANCER may not always result in increased fruit production.

PREPARATION OF SPRAY

Half-fill tank with clean water, add the required quantity of product and agitate during the completion of filling. Frequent or constant agitation of the spray is recommended. Wash out spray tank thoroughly after use.
