



## **HeatTrak® Portable Snow Melting Mat Limited Warranty**

HeatTrak LLC warrants all HeatTrak® Portable Snow Melting Mats against faulty workmanship and use of defective materials for two (2) years from the date of purchase. This warranty can be amended only by a written instrument signed by a duly authorized officer of HeatTrak, LLC. Buyer's exclusive remedy under this warranty shall be to have HeatTrak, LLC, within a reasonable time, repair such goods or supply replacement goods or credit Buyer's account for such goods and accept their return whichever HeatTrak, LLC may elect at its sole discretion. HeatTrak, LLC shall in no event be liable for the cost of removal or installation, for loss or damage to or loss of use of facilities or other property, loss of revenue, loss of use of revenue, loss of anticipated profits, or other damages or costs of any kind whatsoever, whether direct, indirect, incidental, or consequential. Notwithstanding the foregoing, HeatTrak, LLC shall have no liability whatsoever unless: (a) Buyer promptly notifies HeatTrak, LLC in writing after discovery of an alleged nonconformity and includes a detailed explanation of the alleged nonconformity; (b) Buyer promptly returns goods to HeatTrak, LLC postage prepaid, to 3641 Clearview Parkway, Doraville, GA 30340, USA; and (c) HeatTrak LLC's examination of such goods establishes to HeatTrak LLC's satisfaction that such alleged nonconformities actually exist and occurred in the cause of proper and normal use and were not caused by accident, misuse, neglect, alteration or improper installation, repair or testing or such other cause outside of the responsibility of HeatTrak, LLC under this Limited Warranty.

**THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER REPRESENTATIONS, WARRANTIES, OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT, AND OF ANY OTHER OBLIGATION OR LIABILITY ON THE PART OF HEATTRAK, LLC, WHETHER BY STATUTE, CONTRACT, STRICT LIABILITY, TORT OR OTHERWISE.**
