TERMS AND CONDITIONS – A brief Overview

Reservation Request

- All renters must, complete the Rental Reservation Form and pay a \$500.00 security deposit by check to reserve the requested rental date.
- The Security Deposit will be refunded the week following the event, provided that the full conditions of this agreement have been met, the facility is cleaned and restored to its pre-event state, and there has been no damage to or loss of Club property or equipment.

Rental Agreement

- Once the rental is approved by HYC, a Facilities Rental Agreement will be emailed.
- The Facilities Rental Agreement must be signed and completed with the remaining balance due in full within 30 days of the approved request to secure the event date.
- Cancellations made prior to 30 days in advance of the event will be refunded 50% of payment. No refund will be granted if canceled within 30 days of the event.

Available Dates

- The club is not available for non-member rentals from June 15th through September 15th.
- The club is not available for rentals on Sundays in July or August.
- Rental dates between July 1st and Labor Day may not be reserved before February 1st of the event year.
- Rental dates before July 1st and after Labor Day may be reserved on a first come first served basis.
- Rentals are for a duration of five hours, excluding set up.

Member Status

- Member rates apply to members and their dependents only (not extended family)
- Member gatherings of fewer than 25 guests do not require a rental reservation.
- Members must be in good standing for two years to obtain member rates.

Event Manager & Parking Attendant

- An Event Manager is required for all rentals with 50 or more guests.
- The Event Manager will be on site and available to the renter and Bar Management for the full duration of the event, i.e., beginning one-hour prior to and the duration of the 5-hour rental.
- A Parking attendant will assist with lawn parking at the beginning of the event. Please advise your guests.

Event Set-up and Close

- The club will be open for set up on the day of the event, 1-week advance notice of start time required.
- The club bar will be stocked and have special, pre-arranged requests ready.
