

Rules & Regulations

Thank you for choosing to hold your Private Event with Edelweiss Cruises & Boat Tours (Milwaukee River Cruise Line). We look forward to hosting your group and providing a safe and enjoyable venue to you. Below are rules and regulations that are required to be followed by all passengers in attendance to ensure the safety of passengers and staff. The Captain is the authority on board and will have the final determination if any of the rules or regulations are not followed. In the event that the rules or regulations are not followed, our Captain maintains the right to return your cruise to the dock where passengers will disembark and the event will be terminated WITHOUT a refund and the retention of your \$1000 security deposit by Edelweiss Cruises. Your \$1000 deposit will be held as a pending charge in your account and released the following business day of your cruise if all regulations are abided by.

COVID 19

Due to the Covid 19 outbreak and regulations set forth by the state of Wisconsin, all passengers will be required to follow any requirement set forth by the CDC and City of Milwaukee in place at the time of your cruise.

OUTSIDE FOOD & BEVERAGE

NO outside food or beverage is permitted on board unless permission is granted by your Special Events Coordinator at the time of booking. A member or members of the Edelweiss Staff will be checking all bags prior to boarding. If outside beverage or non approved food is discovered in this process, it will be disposed of immediately on site and NOT returned to the guest at the completion of the event.

ILLEGAL ACTIVITY

All City of Milwaukee and State of Wisconsin laws apply to our vessels while at the dock and on the water. If any illegal substances, drugs or public indecency are seen on board, the boat will immediately return to the home dock and the authorities will be contacted to meet the vessel there. All passengers will be subject to a search by authorities prior to disembarking.

SELLING OF TICKETS

Edelweiss Cruises DOES NOT allow tickets to be sold for private charters without express written permission by your Special Event Coordinator at time of booking. No tickets are to be sold by our company or by the client to the public. Edelweiss vessels that are booked privately will NOT be allowed to sell tickets to their event.

WEAPONS / FIREARMS

Edelweiss Cruises does not allow weapons or firearms of any kind on board

UNDERAGE DRINKING

All passengers partaking in alcoholic beverages **MUST** be 21 years of age or older. This includes underage passengers that are attending with their parents or guardians. No exceptions will be made for any guest under the age of 21.

DECOR/EARLY BOARDING

A maximum of 5 passengers will be allowed to board the boat 30 minutes prior to boarding for decorating/setting up purposes. Any additional guests found on board or earlier than 30 minutes will be escorted off the vessel. If additional time is required, arrangements will need to be made at the time of booking for an additional fee.
