#### Sub: <u>Summary of Proceeding of 36<sup>th</sup> Annual general Meeting(AGM) pursuant to Regulation</u> 30 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015

The 36<sup>th</sup> Annual General Meeting (AGM) of the Company was held today, i.e. Thursday, 24<sup>th</sup> September, 2020 through Video Conferencing / Other Audio Visual Means in conformity with the regulatory provisions and Circulars issued by the Ministry of Corporate Affairs, Government of India. The Meeting commenced at 12.05 p.m. (1ST).

Ms. Shuvanki Purakayastha, Company Secretary, welcomed all the Shareholders, Directors and other panelists to the 36<sup>th</sup> AGM of the Company.

Mr. Ajay Kumar Mall, Chairman and Managing Director of the Company, chaired the 36<sup>th</sup> AGM. The requisite quorum being present, the Chairman called the meeting to order.

Thereafter, the Chairman began his speech with a welcome address to all the shareholders and his colleagues on the Board of Directors. He briefed the shareholders about the Company's operations which included highlights on business performance, financials, outlook, future projects, CSR goals etc. He further informed that there was no qualification, reservation or adverse remark in the Auditors' Report on the Financial Statements and report of the Secretarial Auditor.

With the permission of the members, the Notice convening the AGM, Directors Report, Audited Financial Statements for the Financial Year ended 31<sup>st</sup> March, 2020 and Auditors Report thereon were taken as read.

The members were informed that pursuant to the provisions of Companies Act, 2013 and SEBI (listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided facility to cast their votes electronically, on all resolutions set forth in the Notice convening the 36th AGM of the Company. The facility to cast votes through remote e-voting was provided to the Members from 9.00 a.m. on 21st September, 2020 till 5.00 p.m. on 23rd September, 2020. Facility for e-voting was also provided during the Meeting to those Members who had not cast their votes through remote e-voting. The e-voting window for such shareholders was active throughout the meeting and remained so till 15 minutes after the conclusion of the meeting.

The Members were then briefed on the Ordinary and Special Business items covered in the AGM Notice dated 31<sup>st</sup> July, 2020 and listed under Serial Nos. 1 to 6 below:

#### **Odinary Business**

1. To receive, consider and adopt:

a) Audited Financial Statements of the Company for the financial year ended 31st March, 2020 together with the Reports of Board of Directors and Auditors thereon.





b) Audited Consolidated Financial Statements of the Company for the financial year ended 31st March, 2020 together with the Report of Auditors thereon.

- 2. To declare Dividend on equity shares of the Company for the Financial Year ended on 31st March, 2020.
- 3. To appoint a Director in place of Mr. Giriraj Kumar Mall (DIN: 01043022), who retires by rotation and being eligible, offers himself for re-appointment.
- 4. To appoint M/s. S. K. Singhania & Co., Chartered Accountants as Statutory Auditors and fix their remuneration.

#### **Special Business**

5. To appoint Mr. Gaurav Kumar Choudhary (DIN: 01729690) as an Independent Director.

6. To appoint of Mr. Arindam Bose (DIN: 05202786) as a Non-Executive Non-Independent Director.

The Members who had registered themselves as Speakers were given the opportunity to ask questions or seek clarifications on the Agenda items. Thereafter, the Chairman responded to the queries raised / clarifications sought by the Members who spoke at the Meeting.

The Chairman advised the Members that the Voting Results, along with the Report of Scrutinizer M/s. Rakhi Dasgupta & Associates, would be made available on the Company's website and also on the website of NSDL within 48 hours of conclusion of the meeting. The Voting Results would also be forwarded to the BSE Limited, where the Company's shares are listed.

The Chairman, thereafter, thanked all the members for their participation at the AGM and wished them a healthy and safe future.

The meeting concluded at 1.16 p.m. (IST)

All the Resolutions for consideration at the 36<sup>th</sup> AGM in respect of the items set out in the Notice dated 31<sup>st</sup> July, 2020, have been passed by the Members with requisite majority through remote e-voting and e-voting during the AGM.

- In view of the massive outbreak of the COVID-19 pandemic, social distancing is a norm to be followed and pursuant to the Circular No. 14/2020 dated 8th April, 2020, Circular No.17/2020 dated 13th April, 2020 issued by the Ministry of Corporate Affairs followed by Circular No. 20/2020 dated 5th May, 2020, physical attendance of the Members to the AGM venue is not required and Annual General Meeting (AGM) be held through Video Conferencing (VC) or Other Audio Visual Means (OAVM). Hence, Members can attend and participate in the ensuing AGM through VC/OAVM.
- 2. In keeping with Regulation 44(1) and 44(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and as prescribed under Rule 20 (4)(xiii) of the Companies (Management and Administration) Rules, 2014 for the purpose of ensuring that Members who have cast their votes through remote e-voting do not vote again during the general meeting, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of general meeting, to only such details relating to Members who have cast their votes through remote evoting, such as their names, DP ID & Client ID / folios, number of shares held but not the manner in which they have voted.
- 8. Accordingly, NSDL, the remote e-voting agency provided us with the names, DP ID & Client ID / folios and shareholding of the members who had cast their votes through remote e-voting.
