

TERMS AND CONDITIONS Productivity Bundle Promotion

These terms and conditions (Terms and Conditions) were last updated on 31 March 2021.

Ultimaker APAC Pte.Ltd (Ultimaker) together with authorized local sales partners and resellers in the APAC region (each Sales Partner) offer end-customers (the Customer) the opportunity to receive a 20% discount on the Ultimaker S-line 3D printers upon the purchase of 3 (three) or more Ultimaker S5 Pro Bundle, Ultimaker S5 or Ultimaker S3 (in any combination), subject to the terms and conditions set out herein (the Promotion).

1. Promotion dates

Promotion dates: 1 April 2021 up to and including 20 June 2021. Purchases dated prior to or after this timeframe are not eligible for the Promotion.

Note: The Promotion will follow Singapore time. The Promotion will start at 12.01 am and will end on midnight of the last day of the Promotion.

2. Promotion

The Promotion is applicable only to end-customers; not for trade purchases.

Upon the purchase of 3 (three) or more Ultimaker S5 Pro Bundle (consisting of (i) an Ultimaker S5, (ii) an Ultimaker Material Station and (iii) an Ultimaker S5 Air Manager), Ultimaker S5 and/or Ultimaker S3 (in any combination), the Customer will receive a discount of 20% on these purchased printers and hardware add-ons. The purchases have to be made at the same time in order to be eligible for the Promotion.

Only Customers who purchased 3 (three) or more Ultimaker S5 Pro Bundle, Ultimaker S5 and / or Ultimaker S3 (in any combination) from a Sales Partner in the APAC region are eligible for participation in this Promotion. Other Ultimaker products or Ultimaker products purchased in a different region are not part of this Promotion.

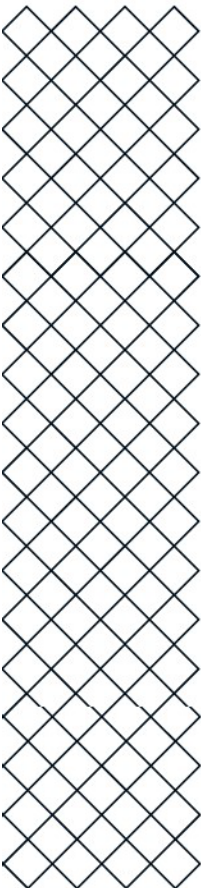
Customer will receive 20% discount on each Ultimaker S-line 3D printers and hardware add-ons purchased at the same time.

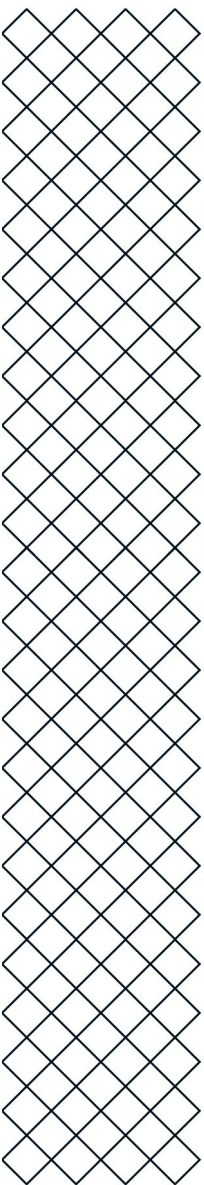
3. Miscellaneous
