**Laboratory note:** The estimated concentration of the unknown peak in the sample is 5.29%. Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)- $\delta$ 8-THC or  $\delta$ 9-THC. At this time there are no reference standards available for (+)- $\delta$ 8-THC. (+)- $\delta$ 8-THC is a different compound from the main (-)- $\delta$ 8-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- $\delta$ 8-THC and  $\delta$ 9-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)- $\delta$ 8-THC and  $\delta$ 9-THC with the majority, if not all, of the concentration being (+)- $\delta$ 8-THC. Total (+)- $\delta$ 8-THC concentration is estimated to be: 89.61%
