4. First Aid Measures

Eye Contact:

6. Accidental Release Measures

Small Spill: Use appropriate tools to put the spilled chemical in a convenient waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

Large Spill: Finish cleaning by spreading water on the contaminated surface and allow evacuating through the sanitary system.

Spills and Disposal: Floors may be slippery. Prevent spills and contaminated wash water from entering sewers and bodies of open water. Contain spills with inert material, such as sand or earth; scoop absorbed material into containers. Dispose of in accordance with all local, state and federal regulations; incineration is preferred.
