Contract Terms of NO LIMIT Fitness & Fight Shop GmbH

General Terms and Conditions regarding Martial Arts Training at No Limit Fitness & Fight Shop GmbH

By signing, I guarantee that all information provided is accurate. I consent to the verification of my identity by making a copy of my ID/Passport. I hereby consent to the disclosure of my data.

Duration:

The registration date is also the renewal date in the respective following year when the contract expires. The duration of time cards can be found on the ticket. Contract pauses or payment deferrals are only possible in special cases with written agreement.

Termination:

Our contract duration is one year from the registration date and must be terminated in writing eight weeks before the end of the expired year if you wish to cancel. Otherwise, the contract will automatically renew for another year. There is no refund for time cards, and they are non-transferable.

Special Rates and Agreements:

Memberships, as well as time cards with special rates (Silver and Gold), are allocated a spot in the assigned classes after reservation. In the event of full capacity, these spots may still be canceled or rescheduled since members with only one class booking in the respective group must be given preference to avoid any disadvantage. If a special agreement has been agreed upon that deviates from the contract template, it will be entered later (including handwritten) by the managing director and declared valid with a signature and stamp. Otherwise, registration fees and payment method/date must always be adhered to and can be found in the contract.

Payment:

Payment must be made as indicated either on the first or fifteenth of the month and is considered paid only from the date the money is received in the account or paid on-site. In the event of late payment, we must unfortunately charge reminder fees of five euros per reminder. The SEPA direct debit mandate must be provided as security for any chosen payment method, and the participant's account may be automatically charged on time. In the case of a direct debit bounce, the participant bears the additional costs.

Training:

The booked class schedule may vary in terms of times and trainers both during membership and when using time cards and can be changed. Participants are assigned to a specific class. A class change must be requested and approved. Participants with a Silver or Gold membership/time card must reserve their spot for the upcoming week in advance. For all participants, confirmation of participation must be received at the latest on the same day, up to 2 hours before the start of the class. Under certain circumstances, it may happen that confirmation of participation is not received, and the class may not take place due to low demand. In this case, we are happy to offer an alternative class. This should always be requested in such a case. Free training for members is generally possible on our training area at no additional cost, but only after consultation and reservation. For participants under 18 years old, this form acknowledges the parents' consent that they are allowed to train unsupervised.

Liability:

No Limit Fitness & Fight Shop GmbH is not liable for valuables and property of customers. Additionally, we would like to note that for participants under 18 years old, the journey home is also to be organized and supervised by the parents. Nonetheless, we request general information regarding whether the underage participant will be picked up or will go home alone. Furthermore, it is important to reiterate that this is a contact sport, and there is a possibility of injury. We also do not assume any liability for physical or other injuries that may occur.

Hygiene:

The training area should always be entered with sportswear, indoor shoes, or barefoot. We ask participants to bring a towel to training.
