# 3. Pricing

#### **DEEDS:**

€39.99 per annum for each property.

€49.99 per annum for each commercial / investment property.

# WILLS:

€9.99 per annum for one/two Wills

All payments by Direct Debit Mandate.

Annual payment is due on anniversary of the first payment. If there is any default on the part of your bank in honouring the Mandate, you will be liable to pay interest on the unpaid amount @9.99% per annum compounding annually until paid.

### 4. Release of Deeds

Title Deeds and Wills will only be released to Owner or Legal Personal Representative on receipt of original Authority and photo I.D. or to Owner's Solicitors.

## 5. Liability
