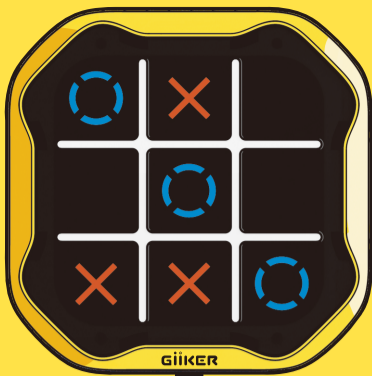

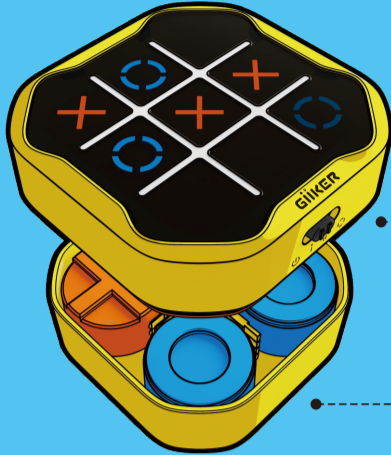

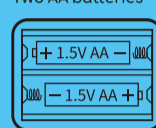
Touch screen console will automatically turn off if no operations for 10 minutes. Switch to turn it on.

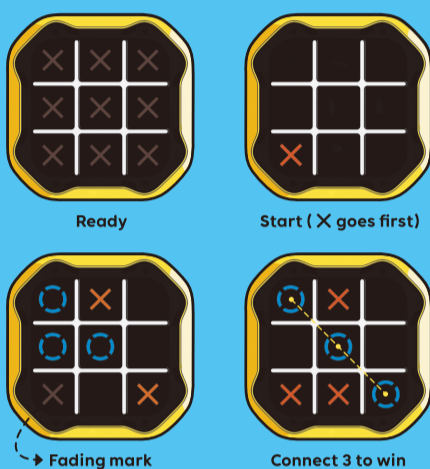

How to play

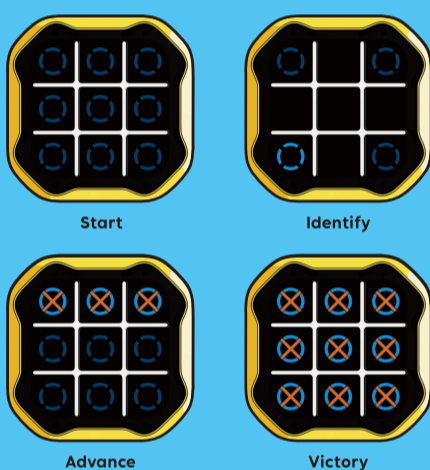

Quick Start

- i Robot Mode ii Head to Head Mode
- X (human) moves first, O (robot) moves next
- The connected 3 tiles will flash when someone wins. Tap the screen to restart.

How to play

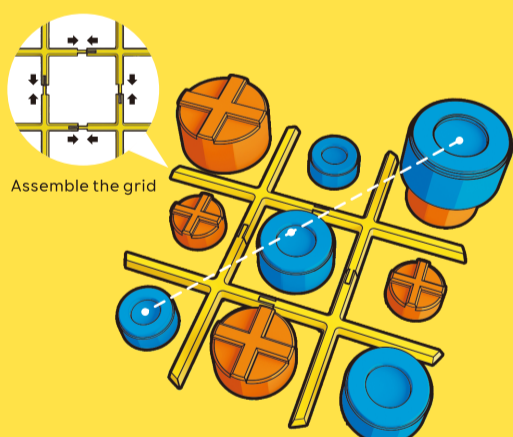
Focus and identify the sequence. There are 9 difficulties, with 3 stages each. Clear all 9 difficulties in one go to beat the game!

Quick Start

- In each turn, choose to "place" or "move" a piece
- Place**
Place a piece on an empty tile, or cover any smaller pieces
- Move**
Move a piece to an empty tile or cover any smaller pieces
 - Only the top piece can be moved
 - If a draw occurs after a move, the opposing player wins.

FAQ

1. Why does the touch screen console suddenly shut down?

The console will automatically turn off if low battery or no operations for 10 minutes. Replace the battery or flick the switch to wake up.

2. How to distinguish between robot mode and head-to-head mode?

In robot mode, after X (human) plays, O (robot) will automatical play.

In head-to-head mode, after X (player 1) plays, wait for O (player 2) to play.

Notes

- 1.Never abuse, throw, drop, puncture, violently kick or step on the product. This can damage the product.
- 2.The product is not water resistant. Do not drop the product into water. Do not leave the product out in the rain or near a source of moisture.
- 3.Do not place the product near a source of heat. Operate and store the product between 0 °C and 40 °C.
- 4.Leakage of battery acid can cause personal injury as well as damage to your Tic-Tac-Toe Bolt. If battery leakage occurs, thoroughly wash the affected skin and cloths. Keep battery acid away from your eyes and mouth. Leaking batteries may make popping sounds.
To avoid battery leakage:
Do not mix different brands of batteries; Do not mix old and new batteries; Do not mix alkaline, standard (carbon-zinc), or re-chargeable batteries; Do no leave used batteries in the Tic-Tac-Toe Bolt; Do not leave batteries in the Tic-Tac-Toe Bolt for long periods of time of non-use; Do not put the batteries backwards. Make sure the positive (+) and negative (-) ends are facing the correct direction. Do not dispose of batteries in a fire.
- 5.The supply terminals are not to be short-circuited.
- 6.Not suitable for children under 3 years. Small parts. Choking hazard.
- 7.Read this manual carefully before use and retain it for future reference.
